

**THE LOWE'S PROVEMBER SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

The Lowe's PROvember Sweepstakes ("**Sweepstakes**") is sponsored by Lowe's Home Centers, LLC. ("**Sponsor**"), 1000 Lowe's Blvd., Mooresville, NC 28117 and is administered by Prize Logic, LLC, ("**Administrator**"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

1. **SWEEPSTAKES PERIOD:** The Sweepstakes begins on October 28, 2020 at 12:00 PM Eastern Time ("**ET**") and ends on November 25, 2020 at 11:59:59 PM ET ("**Sweepstakes Period**"). The Administrator's computer is the Sweepstakes official clock.
2. **ELIGIBILITY:** This Sweepstakes is open only to legal U.S. residents of the fifty (50) United States and the District of Columbia who are
  - (i) at least eighteen (18) years old and the age of majority in their state of residence at the time of participation; and
  - (ii) a PRO (defined as someone who works for or provides services in any of the following industries: construction, home improvement/repair, property management, and/or maintenance management sectors, or other sector as determined by Lowe's in Lowe's sole discretion) ("**PRO**"); and
  - (iii) a LowesForPros.com registered account holder at the time of entry (it is free to register for a LowesForPros.com account), subject to [LowesforPros.com Terms and Conditions](#); and
  - (iv) and who have a **valid United States driver's license required to claim a prize.**

Employees of Sponsor, Administrator, Stanley Black & Decker, Inc., General Motors, LLC, and each of their respective parent companies, subsidiaries, affiliates, advertising, production, and promotion agencies and each of their immediate family members (e.g., spouse, parent, child, sibling, and each of the foregoing entities' respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and LowesForPros.com account e-mail address will be the physical address and e-mail address submitted at the time of Sweepstakes entry. Entrants will not be allowed to change their physical address or e-mail address after submission.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant may visit ProvemberSweepstakes.com ("**Website**") and complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address (e-mail must be the e-mail address associated with his/her LowesForPros.com account), phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the applicable pool ("**Pool**") based on his/her state of residence. The Pools are as follows:

**Entry Limit:** There is a limit of one (1) entry per person during the Sweepstakes Period. If more than one (1) entry is received from the same person, and/or LowesForPros.com e-mail address, the entries may, at the Sponsor’s sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected, in Sponsor’s or Administrator’s sole discretion, that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor’s sole discretion, may not be eligible to win a prize.

**IMPORTANT:** IF AN ENTRANT ENTERS THIS SWEEPSTAKES ON HIS/HER MOBILE DEVICE, DATA RATES MAY APPLY. 4. **RANDOM DRAWING:** On or around November 30, 2020, the Administrator will randomly select one (1) potential winner from all eligible entries received for each Pool, for a total of three (3) potential winners. Each selected winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules. Once verified in compliance with these Official Rules, including completing any additional documentation and releases, as may be required, potential winner will be deemed a “**Winner**”.

5. **PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**

**A. Prizes (3 total; 1 per Pool):** Each prize (“**Prize**”) includes:

- (1) One 2021 Chevrolet Silverado selected at Sponsor’s sole discretion (“**Truck**”);
- (2) Select DeWalt Tools, selected at Sponsor’s sole discretion (“**Tools**”); and
- (3) One (1) \$23,000.00 check, payable to Winner intended to help offset any potential tax liability and/or Truck fees related to acceptance of the Prize (“**Check**”). Consult your tax advisor.

The Truck make and model specifications, as well as all other details of the Truck will be determined by Sponsor, in its sole discretion.

Except for the Check, no cash equivalent will be awarded for any Prize. Each Winner must take delivery of the Truck, at his or her own expense, at a dealership selected by Sponsor based on proximity to Winner’s residence, as set forth in Winner’s entry, within fifteen days (15) of

Sponsor or Administrator will contact the Winner regarding timing of delivery of the Truck to the applicable dealership. Tools and Check shall be sent directly to Winner's address as set forth in Winner's entry. No other delivery option for any Prize will be available.

**Each Winner is responsible for all taxes and expenses, including but not limited to: sales tax, luxury tax, destination charges, registration, title and license fees, insurance and all other costs incurred in claiming, registering or using his/her Prize. Each Winner must present his or her valid driver's license and provide satisfactory proof of liability insurance prior to pick up of the Truck.** The Truck details and availability are subject to change at Sponsor's sole discretion. **B. Total ARV:** The total ARV of all Prizes is \$ 228,579.

**C. Odds of Winning:** The odds of winning a Prize depend on the number of eligible Sweepstakes entries received for each Pool.

**D. General Conditions:** There is a limit of one (1) Prize per person. In no event will more than three (3) Prizes (one [1] per Pool), be awarded. After the random drawing, Administrator will notify the potential winner via e-mail at the e-mail address provided at the time of registration. Each potential winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the respective Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Each potential winner may be subject to a background check before his/her Prize is awarded. Sponsor reserves the right to disqualify the potential winner based on the results of such background check if Sponsor determines in its sole discretion that awarding a Prize to any such individual might reflect negatively on the Sponsor, or if any such potential winner does not meet the eligibility requirements, including being a PRO.

Sponsor will attempt to notify each potential winner as set forth above, but neither Sponsor, nor its parent or affiliates, are responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a potential winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any potential winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a Prize of equal or greater value in case of unavailability of a Prize or force majeure, at Sponsor's sole and absolute discretion. Released Parties (as defined below) shall not be held responsible for any delays in awarding a Prize for any reason.

- (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail notifications or postal mail;
- (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability;
- (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion;
- (iv) any technical, mechanical, printing or typographical or other error;
- (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information;
- (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes;
- (vii) any injuries, losses or damages of any kind to person(s) including, without limitation, death, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any Prize or participation in this Sweepstakes or any Sweepstakes-related activities; and/or
- (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules.

In no event will more Prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more potential winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winners.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NORTH CAROLINA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN CHARLOTTE, NORTH CAROLINA. THE**

**REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR RELEASED PARTIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR FROM THE END OF THE SWEEPSTAKES PERIOD, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.**
